# HOTEL DUE DILIGENCE

For the object inspection / DD we need the following documents:

- Full address
- Details of the hotel operator and the existing lease agreement
- Area datas and floor plans
- If available: Building description & list of renovation measures over the last years
- Current object images, interior and exterior
- Land register extract & Cadastral map
- For plots of land: Information on building rights (designation in the land use plan), planning security, site occupancy index (GRZ) and floor space index (GFZ), development, contaminated sites, building encumbrances and easements.
- Purchase price & deal structure (Asset Deal vs. Share Deal)
- Proof of the direct mandate or confirmation of permission to sell the hotel, the authorization from the owner



#### HOTEL DUE DILIGENCE

Requirements for the DD:

- Only Off-market offerings; no prior dispersal at the hotel market
- Proof of valid & direct mandate
- Direct access to the owner (via broker or his cooperation partner) after initial assessment and submission of LOI

Base for offer: If you are not the owner, we ask you to provide written proof that you have been commissioned to sell the property when you send us the offer. Our requirement profile does not constitute an offer to conclude a brokerage contract. A brokerage contract is only concluded by prior written acceptance by us.
